

## 2023 People's Choice Award T&Cs

### Terms and conditions

Before voting for your favourite image in the 2023 People's Choice Award, please read the following terms and conditions.

#### 1. About the 2023 People's Choice Award vote

- (1) The 2023 Wildlife Photography Competition is owned by Cornwall Wildlife Trust.
- (2) The 2023 Wildlife Photography Competition, 2023 People's Choice Award Vote ("the vote"), organised by Cornwall Wildlife Trust, comprises an online vote in which one winning image is selected from 30 images chosen by Cornwall Wildlife Trust.
- (3) Voters will be asked to select their image and submit their vote by completing the 2023 People's Choice Award form: <https://www.cornwallwildlifetrust.org.uk/2023-peoples-choice-award>

#### 2. The 2023 Wildlife Photography Competition, 2023 People's Choice Award vote Terms and Conditions of Entry

- (1) Votes must be cast by 00:00 GMT on Monday 20<sup>th</sup> November 2023.
- (2) One vote is permitted per person and will be restricted to one vote per email address.
- (3) Those who cast a vote must be over 18 years of age.
- (4) By entering the vote, voters agree to the terms and conditions of entry.
- (5) In the event of unforeseen circumstances, Cornwall Wildlife Trust reserves the right to cancel, modify, extend or suspend the vote.
- (6) All details and other restrictions applying to the vote not specified in these Terms and Conditions shall be determined by Cornwall Wildlife Trust its sole discretion.
- (7) Cornwall Wildlife Trust reserves the right to modify these Terms and Conditions without prior notice.
- (8) By entering the vote, you confirm to Cornwall Wildlife Trust that all information submitted by you is correct and that you have complied fully with these Terms and Conditions. Cornwall Wildlife Trust reserves the right to verify the eligibility of voters. Automated votes will be invalid. Votes that do not comply with these Terms and Conditions will be invalid.
- (9) Cornwall Wildlife Trust reserves its right to discount invalid votes and may withhold or withdraw any Award which has been given as a result of invalid votes.

#### 3. The 2023 Wildlife Photography Competition, People's Choice Award

- (1) The winning image will be the image with the highest number of votes.
- (2) The winning image will be displayed on Cornwall Wildlife Trust's website, social media channels, email marketing and offline, including Wild Cornwall magazines.

#### 4. Indemnity and Limitation of Liability

(1) To the maximum extent permitted by law, Cornwall Wildlife Trust excludes its liability for any loss, damage, injury, cost or expense suffered by you, whether directly or indirectly and howsoever caused, in connection with the vote and use of any prize. Nothing in these terms and conditions shall exclude Cornwall Wildlife Trust's liability for death or personal injury arising from Cornwall Wildlife Trust's own negligence or any other liability that cannot, as a matter of law, be excluded.

(2) You agree to indemnify Cornwall Wildlife Trust and keep Cornwall Wildlife Trust indemnified against any loss, damage, injury, cost or expense suffered by Cornwall Wildlife Trust as a result of your vote, including (but not limited to) any claim of infringement of intellectual property rights made by any third party.

(2) These Terms and Conditions shall be governed and construed in accordance with English Law and will be subject to the exclusive jurisdiction of the English courts.
