For more than 60 years, Cornwall Wildlife Trust has been working to protect Cornwall's wildlife and wild places. Although a local, independent charity, we are part of a national movement of 46 Wildlife Trusts, all with a shared purpose.

Our vision is of a Cornwall where nature thrives. Where currently rare and threatened species are once again a normal part of our countryside, skies, and seas. Where children grow up surrounded by wildlife. And where we're all connecting with and taking action for nature – benefiting our health and wellbeing, and ensuring a future for nature in Cornwall.

### **About Tor to Shore**





Tor to shore is a new project located in the Par River catchment and surrounding area - from the granite boulders of Helman Tor, Cornwall Wildlife Trust's largest nature reserve, to the spectacular waters of St Austell Bay, home to important seagrass and maerl habitats.

Tor to Shore is made possible with The National Lottery Heritage Fund. Thanks to National Lottery players, the project aims to establish a thriving land and seascape, where local communities and businesses are engaging with, taking action for, and benefiting from nature. Key project goals include:

- implementing rewilding principles at Helman Tor, helping nature once again take the lead at one of the UK's most important sites for wildlife
- working with local farmers and fishers to increase sustainable practices, contributing to greater flood prevention, a reduction in harmful pesticides and agricultural run-off, and better protection for marine species and habitats
- creating a Voluntary Marine Nature Reserve in St Austell Bay, supported by and benefiting local communities and businesses
- engaging communities, including those from excluded backgrounds, who are acting for wildlife and benefiting from nature.

Cornwall Wildlife Trust aims for this to be a six-year project, starting with the one-year development phase, followed by a five-year delivery phase.

#### Role summary

This role will co-ordinate the development of our marine surveying, engagement, and fisheries liaison work for Tor to Shore. This will be achieved through engagement with catchment stakeholders such as fishers, marine businesses, and community groups via the facilitation of meetings, training, workshops, and events. The role will also coordinate a programme of marine survey work to capture data, ultimately improving our understanding of St Austell Bay's marine species and key blue carbon habitats to inform project activities.

# Responsibilities

- Develop trust and foster positive working relationships with coastal and marine stakeholders. This includes community groups, harbour authorities, fishing industry representatives, conservation bodies, managing bodies, recreational industries, and other local coastal businesses within St Austell Bay. The aim of this work is to encourage an improved understanding of the value of our marine environment and buy-in for marine nature recovery initiatives (these could include reducing negative impacts on key habitats and developing more sustainable practices). This will be done via engagement with stakeholders, including one-to-one meetings, workshops, and events.
- In particular, develop relationships with fishers and fishing businesses within the area from a
  range of catching sectors. This may involve joining fishers at sea to identify impacts, barriers,
  and potential for development of fisher-led project ideas to improve the sustainability of
  their practices for the delivery phase of Tor to Shore.
- Work with local marine community groups to:
  - raise awareness of St Austell Bay's blue carbon habitats (seagrass and maerl) and their value





- identify priorities and scope potential for a local Charter of Sea (a plan of action to promote nature recovery in the local marine environment) for St Austell Bay.
- Coordinate a programme of marine surveys, including shore-based sea watches, intertidal, and subtidal surveys, and water quality sampling, in partnership with Cornwall Wildlife Trust's Marine Conservation Officers and trained volunteers to collect data on marine species and habitats.
- Use data collected to inform stakeholder and public engagement and project development.
- Support the Tor to Shore Project manager and other project staff with the development of the delivery phase of Tor to Shore grant application and project plans.
- Support the design of data collection and framework development for project evaluation.
- Undertake other work required within the project, including project support, communications, media work and administration.
