Mounts Bay have used their voice to create a list of environmental solutions. The following actions have been voted as the community's **CONSERVATION PRIORITIES** to protect their local marine environment and encourage nature to recover and thrive.

- 1. Fines issued to South West Water and work with them to improve local sewage systems
- 2. Work with harbour authorities, fishers and existing projects to reduce plastics released from net repair and damaged gear discards
- 3. Engage local farmers on agricultural impact on marine environment
- 1. Introduce a recycling/hire scheme for beach toys and bodyboards
- 2. Introduce a 'tourist tax' of which a percentage benefits local environmental projects, community groups and charities
- 3. Accommodation providers to supply patrons with educational resources about the local marine wildlife and environment






- 1. Introduce ocean conservation element as part of the national school curriculum
- 2. Have the strategy to target all generations, from school to pensioners
- 3. Provide better education or information on what the Marine Conservation Zone (MCZ) means
- Reduce/restrict benthic trawling within the Marine Conservation Zone
- 2. Introduction of no netting zone within the bay
- 3. Better enforcement of existing legislation for local fisheries





- 1. Introduce licensing Owildlife watching operators 1. Introduce licensing and compulsory wildlife disturbance training for
 - 2. Better enforcement of fines pertaining to wildlife disturbance / crime
 - 3. Provide information on how to behave responsibly around wildlife at launching points for all watercraft

- 2. Work with local businesses and larger companies on reducing plastic use and using more sustainable practices by promoting existing schemes from Sustainable Penzance
- 3. Engage local farmers on agricultural impact on marine environment

- 1. Marine education events and resources to be inclusive and accessible for everyone
- 2. Interpretation boards to be placed in popular areas and visitor attractions
- 3. School engagement to be continuous and revisited through every school year
- Local councils to commit to supporting a more ecologically healthy sea and rethink how ocean is taken into account in planning and decision making at local level
- 2. Develop a joint strategy linking around local parishes for maximum impact
- 3. Work with landowners in collaboration to encourage conservation of adjoining marine environment
- 1. Introduce management to protect vulnerable seagrass beds (e.g. no
 - 2. Better fisheries management (voluntary or regulatory) to stops impacts on seagrass beds
 - 3. Better enforcement of infringement of current MCZ restrictions
 - 1. Awareness campaign of specific effects of climate change on Mounts Bay area and potential solutions
 - 2. Introduce electric buses to replace current public transport
 - 3. Introduce and promote blue carbon opportunities in the area (e.g. seagrass restoration)
